USES

ENVIROSHIELD is recommended for applications requiring multiple releases, superior surface finish with high gloss and easy touch-up for seamless production cycles. **ENVIROSHIELD** can be used for releasing epoxies, phenolics, polyester resins, polyamides, polybismaleimides, various rubbers and elastomers.

HOW TO USE

Before applying **ENVIROSHIELD**:

- ✓ All previous surface treatments, residues, waxes or oils should be removed using a ZYVAX mold and part cleaner.
- ✓ The mold should be properly sealed with a ZYVAX mold sealer according to the technical data sheet.
- 1. Apply one light coat of **ENVIROSHIELD** to a small area of the mold (1-2 ft²; 0.2 m²) using a clean, lint-free cloth or hand sprayer.
- 2. Wait approximately 60 seconds, and then wipe the mold surface dry using a separate clean cloth.

 Make sure the entire mold surface is coated in this manner, slightly over-lapping the last coated area if you are applying in sections. Be certain that all contours are adequately coated.
- 3. Wait for a minimum of 15 minutes.
- 4. Apply a second coat of **ENVIROSHIELD** in the same way, and wait for a minimum of 30 minutes before using mold. For mold temperatures above 80 °C (180 °F), apply one very light coat of **ENVIROSHIELD** and do not wipe off. Wait for a minimum of 15 minutes before using mold.
 - For touch-up, apply one coat of **ENVIROSHIELD** as above.

STORAGE & SHELF LIFE

Store product between 5 °C and 30 °C (41 °F and 86 °F). Shelf life is 18 months from the date of manufacture, in the original unopened container.
